VOTING FREQUENTLY ASKED QUESTIONS

HOW DO I VOTE?

IF YOU ARE REGISTERED TO VOTE WITH A CURRENT ADDRESS, A MAIL BALLOT WILL BE SENT TO THE ADDRESS ASSOCIATED WITH YOUR VOTER REGISTRATION. IF YOU PREFER, YOU CAN VOTE IN PERSON AT A VOTER SERVICE AND POLLING CENTER STARTING OCTOBER 26.

HOW DO I KNOW IF I AM REGISTERED TO VOTE?

YOU CAN GO TO WWW.GOVOTECOLORADO.COM TO CHECK YOUR REGISTRATION. IF YOU ARE REGISTERED AND YOU NEED TO UPDATE YOUR ADDRESS, YOU CAN DO THIS AT THE SAME TIME.

WHAT IF I AM NOT A REGISTERED VOTER?

YOU CAN REGISTER TO VOTE AT ANY TIME UP TO AND INCLUDING ELECTION DAY AT A VOTER SERVICE AND POLLING CENTER IN YOUR COUNTY OR AT YOUR COUNTY CLERK'S OFFICE, OR BY GOING TO WWW.GOVOTECOLORADO.COM (IF YOU HAVE A COLORADO DRIVER'S LICENSE OR STATE ID CARD). HOWEVER, IN ORDER TO HAVE A BALLOT MAILED TO YOU, YOU NEED TO REGISTER ON OR BEFORE OCTOBER 26, 2015.
